Mayor Jasso called the meeting to order at 9:00 a.m. and led the Pledge of Allegiance.

1. Approval of an Election Resolution for the 2016 Municipal Election

Mr. Sera stated that the resolution being presented was required by the State in order to conduct the Municipal Election scheduled for March 1, 2016. He stated that the resolution announced the positions and terms scheduled for election, and also announced the designated the precincts, which are Holy Family Parish Hall and the Mimbres Valley Special Events Center. Mr. Sera noted that the resolution must be posted both in English and Spanish, approved and submitted to the Secretary of State by December 8, 2015. Mr. Sera asked Ms. Jasso if she would like to add anything. Ms. Jasso noted that the four precincts will be combined to two Voter Convenience Centers, and reiterated the two locations previously mentioned.

Mayor Pro Tem Milo asked if the voters could vote at either location. Ms. Jasso clarified that any registered voter can vote at either location.

Mayor Pro Tem Milo moved to approve the 2016 Municipal Election Resolution. Councilor Sanchez seconded the motion; motion carried unanimously.

2. Public Hearing to Consider an application for a Restaurant Beer & Wine Liquor License for Marie's Italian Grill and also to request a waiver as the premises is 160 feet from a church.

Mr. Sera presented the Restaurant Beer & Wine Application to Mayor Jasso and Council. He stated that the liquor license application, which includes a request for a waiver as the premise is 160 feet from a church, is being presented as the new business owner has applied to the New Mexico Regulation and Licensing Department/Alcohol and Gaming Division for the license. Mr. Sera noted that there are other restaurants in the area that also serve alcohol.

Councilor Sanchez asked if the church had signed a letter noting their stand on the liquor license application. The applicant stated that they did, however, the letter was not included in the packet from the State.

Mayor Jasso opened the public hearing for public comment. There were none.

Mayor Jasso closed the public hearing and entertained a motion from Council.

Councilor Sanchez moved to approve the requested application for a Restaurant Beer & Wine Liquor License for Marie's Italian Grill, LLC doing business as Marie's Italian Grill, for use at the proposed location of 110 S. Silver Avenue, Deming, NM 88030, and to approve the waiver as the premises is 160 feet from a church. Councilor Rincon seconded the motion, motion carried unanimously.

3. Closed Session to Discuss the Purchase, Acquisition or Disposal of Real Property Pursuant to NMSA 1978, Section 10-15-1(H)(8)

Mayor Jasso entertained a motion to go into closed session.

ELECTION RESOLUTION CITY OF DEMING, NEW MEXICO Resolution No. 15-37

Be it resolved by the governing body of the City of Deming of that:

- A. A regular municipal election for the election of municipal officers shall be held on March 1, 2016. Polls will open at 7:00 A.M. and close at 7:00 P.M.
- B. At the regular municipal election, persons shall be elected to fill the following elective offices: (use only those offices whose terms expire in 2016, or if a vacancy has occurred in the office of a councilor, trustee, commissioner and/or judge with an expiration term of 2018).
 - 1. One Municipal Judge for a four year term
 - 2. District #2 One Councilor for a four year term
 - 3. District #3 One Councilor for a four year term
- C. Precincts 1-4 are consolidated for the regular municipal election.
- D. The following locations are designated as polling places for the conduct of the regular municipal election:
 - 1. Voters in Consolidated Precincts 1-4 shall vote at either of the following locations:

Holy Family Parish Hall 615 S. Copper Street Deming, NM.

Mimbres Valley Special Events Center 2300 E. Pine Street Deming, NM

E. Absentee Voting. Applications for absentee ballots may be obtained only from the office of the Municipal Clerk. All applications for an absentee ballot must be completed and accepted by the Municipal Clerk prior to 5:00 p.m., February 26, 2016. After 5:00 p.m. on February 26, 2016, all unused absentee ballots will be publicly destroyed by the Municipal Clerk. The Municipal Clerk will accept completed absentee ballots delivered by mail, or in person by the voter casting the absentee ballot, by a member of the voter's immediate family, or by the caregiver to the voter until 7:00 p.m. on March 1, 2016.

Absentee ballots may be marked in person in the office of the Municipal Clerk during the regular hours and days of business, beginning on Tuesday, January 26, 2016 and closing at 5:00 p.m. on Friday, February 26, 2016.

<u>Early Voting.</u> Early voting on paper ballots counted by electronic vote tabulator will be conducted in the office of the Municipal Clerk during the regular hours and days of

business, beginning on Wednesday, February 10, 2016 and closing at 5:00 p.m. on Friday, February 26, 2016.

- F. Persons desiring to register to vote at the regular municipal election must register with the County Clerk of Luna County not later than Tuesday, February 2, 2016 at 5:00 P.M., the date on which the County Clerk will close registration books.
- G. All Declarations of Candidacy shall be filed with the Municipal Clerk on Tuesday, January 5, 2016 between the hours of 8:00 A.M. and 5:00 P.M.
- H. The casting of votes by qualified municipal electors shall be recorded on paper ballots to be counted by the Dominion ICP electronic vote tabulators.
