AGREEMENT:

1. CLEANING REQUIREMENTS: League Director, Organizer, or Sponsor are responsible for insuring that all of the following is cleaned upon completion of park use.
 - A) RESTROOMS
 - B) TRASH BARRELS
 - C) COMPLEX / PARK GROUNDS
 - D) PARKING LOTS

2. RULES: League Director, Organizer, or Sponsor will also make sure the following rules are followed:
 - A) SERVICE GATE AREA – ONLY ONE (1) VEHICLE & CONCESSION ALLOWED IN PARK GRASS AREA.
 - B) LOCK ALL GATES & LOCKS DAILY

3. RESPONSIBILITIES: League Director, Organizer, or Sponsor is responsible for the following:
 - A) PROVIDE LIABILITY INSURANCE (PER OCCURANCE) FOR \$1,000,000 LISTING CITY OF DEMING AS ADDITIONAL INSURED.
 - B) PROVIDE OWN SECURITY DURING PARK / COMPLEX USE.
 - C) SUPERVISE AREA TO INSURE AGAINST VANDALISM OR DESTRUCTION OF CITY PROPERTY.

4. RESERVATIONS: Applications MUST be submitted 15 days prior to the proposed event.

“ABSOLUTELY NO ALCOHOLIC BEVERAGES ARE ALLOWED IN PARKS / COMPLEX GROUNDS”

(League Director, Organizer, or Sponsor will bear the responsibility for enforcement)

“IRRESPONSIBLE LIGHT USAGE WILL NOT BE TOLERATED”

(2 hours minimum use of lights, for a charge of \$15.00, then \$7.50 per hour thereafter)

(Leagues must pay a month in advance for light usage)
